

RFP for Family Site Electric Service Panel Replacement

BID ADDENDUM No. 1

September 10, 2020

To All Interest Bidders:

Scope of work: Include in base price the addition of one ground rod, one ground bridge and wiring.

Clarification. The additional circuit in each 2nd floor bedroom must be 120 volt, 20 amp circuit breaker, wiring and single outlet to be located nearest window facing the front or rear of the dwelling unit.

All circuit breakers must be ground fault rated.

Materials. Square D Homeline is now required. Panels will be 100 amp rated with 30 breaker spaces.

Performance bond is required by Bay City Housing Commission Procurement Policy for all contracts over \$50,000. If your bid is over \$50,000 include the cost for a Performance bonding. Bid bond will not be required.

Page 4, Panels to be Replace. Remove unit 5002, 917 S. Jefferson Street (4 bedroom) from the replacement panel list. The new total is 40 residential service panels to be replaced.

Include a general allowance of \$5,000 to your pricing for unforeseen code requirements. This may include the addition of a 240-volt, 30 amp, four wire circuit, wiring and outlet for a dryer if none is present in dwelling unit or additional cost of bonding a water heater, for example.

Unit price to be added:

Relocate one electric service panel approximately 10 feet (usually to adjoining wall) because current panel does not have access clearance per code. Include disconnect switch, splicing, wiring and proper grounding.
